AREA III AWARDS CRITERIA TOP LADIES

I. JUDGING

All judging in all categories will be done by outside individuals. All entries must be delivered *electronically* by designated date(s) for each award.

II. SYN-LOD COMPETITION

- A. The Area Conference 2020 and 2021 first place winners for Top Lady of the Year will be eligible to enter the Syn-Lod 2021 competition.
- B. The date for the Top Lady of the Year Scrapbook covers should be 2019-2020 and 2020-2021 for the respective fiscal year Area Conference.
- C. Your Scrapbook entry for the 2021 Area III Conference must adhere to the National guidelines criteria for both the Willie Lee Glass and the Ozell Dean Award and cover the period from March 2019-March 2021.
- D. There can only be one winner for each award. There can be no ties.

III. SCRAPBOOKS

All scrapbooks submitted for judging at Area and Syn-Lod must adhere to the following criteria. Entries that do not meet these specifications may be disqualified.

- A. Emphasis should be placed on the five (5) thrusts. (Briefly in no more than fifty words describe each program and/or project.)
- B. Chapter scrapbooks for Top Ladies must not be larger than 16 x 20 inches, 5 inches
- C. All scrapbooks must contain a table of contents page and all pages within the Scrapbook must be numbered
- D. Top Lady of the Year scrapbooks must not be larger than 13 X15 inches, 5 inches tall
- E. Top Lady of the Year scrapbooks must contain a signed letter of endorsement from the chapter
- F. All Chapter scrapbook covers must display the chapter's name, year, and conference theme.
- G. All scrapbooks must be uploaded to designated location by due date.

IV. PORTFOLIOS

Portfolios submitted for judging at Area must adhere to the following criteria. Entries that do not meet these specifications may be disqualified.

- A. Portfolio must not be larger than 16 x 20 l inches, 5 inches tall
- B. All portfolios must contain a table of contents page and all pages within the portfolio must be numbered

C. Portfolio outside cover must display the entrant's name, chapter and year
